## **Local News**

#### Full Partnership June 2022

We would like to extend our gratitude for all of our partners who presented at and attended our recent Full Partnership meeting on 15 June. It was fantastic to hear from so many partners on such important topics for the MSCP.

We heard from Elliot Brunton, Head of Housing and Strategy at Merton, about the impact of poor housing and homelessness on safeguarding families in Merton and how Merton's housing team works with their partners to support these families and young people. Elliot spoke to the partnership about some of the areas he is working with partners to improve – such as housing for care leavers and refreshing the protocol for 16 and 17 year olds at risk of homelessness. He has kindly offered to talk about housing processes and improvement areas with individual agencies so if you would find this helpful please do get in touch with us.

We also discussed the story of Child Q, with Andrew Wadey, Detective Superintendent and Public Protection Lead at South West BCU, who provided an overview of how Merton's safeguarding partnership has responded to the themes raised in this review. It was really valuable to hear from a range of partners on what more we can do together to address some of these issues, such as the adultification of black children and young people, as well as the importance of engaging in healthy professional challenge between agencies. Our Scrutineer and Young Scrutineer will be leading on a piece of thematic scrutiny on adultification; if you would like to be involved in this work, please get in touch with us.

We also had the opportunity to hear from our Independent Scrutineer and Young Scrutineer on their thematic scrutiny on sexual harassment (see more below), and we heard directly from schools and students about some of the good practice we have in Merton. We will also be working on the MSCP's annual report over the coming months so you may hear from our team who are collating information; if you would like to see anything in particular included in the annual report let us know at <u>MertonSCP@merton.gov.uk</u> by the end of July.

### **Thematic Scrutiny on Sexual Harassment**

The MSCP's Independent Scrutineer and Young Scrutineer recently completed their thematic scrutiny on how the MSCP and its partners are working to respond to sexual harassment in schools and colleges. We want to thank all the education settings, and other agencies, as well as the children and young people, who took part in this important work. The sexual harassment scrutiny findings will be shared at the June Full Partnership and shared with Education leads and upcoming sub-groups. It also made a number of recommendations to improve our approach and implementation of these will be overseen in the Quality Assurance and Practice Review Sub-Group.

"We have to trust the people before we'd tell them or report sexual harassment. If we have a bad experience before it puts us off telling them something so personal", Young Person who spoke to Scrutineers as part of the scrutiny.

## Merton Children, Schools and Families Ofsted Inspection 2022

Since the last newsbulletin, Ofsted have published their findings of the recent ILACS Ofsted inspection of Children's Services for the London Borough of Merton on 9th May. Ofsted found the overall effectiveness of Children's Services in Merton to be 'Outstanding'. They found evidence of thoughtful and creative innovative practice with children and families in Merton, which is making a positive

difference to children while making them safer. Ofsted recognised the strength of Merton's multiagency partnerships, at both strategic and operational levels. Thank you to everybody who continues to work so hard to keep children and young people safe in Merton and we are delighted that Children, Schools and Families, along with their partners, have had this recognised. ## Prevent Changes

Merton Prevent referrals should no longer be sent to the Children and Families Hub. In line with national changes, Merton has adopted the Prevent National Referral Form (which is available on the <u>MSCP</u> <u>website</u>) and is sent directly to the police. Every referral is screened and after consideration may be shared with the relevant Local Authority Channel Panel. Channel Panel is an early intervention scheme that supports people who are at risk of radicalisation and provides practical support tailored to individual needs.

## **National News**

#### **Child Safeguarding Practice Review Panel**

The Child Safeguarding Practice Review Panel has published their review into child protection in England following the tragic deaths of Arthur Labinjo-Hughes and Star Hobson. The report found that there had been weaknesses in information sharing and lack of robust critical thinking and challenge between agencies. It found that multi-agency arrangements for protecting children were more fractured and fragmented than they should be and there was insufficient attention to, and investment in, securing the specialist multi-agency expertise required for undertaking investigations and responses to significant harm from abuse and neglect. The report concludes by recommending that multi-agency child protection units – integrated and co-located multi-agency teams staffed by experienced child protection professionals – are established in every local authority area. The report also made some specific recommendations for local safeguarding partnerships which have been considered at the MSCP Executive and will be brought to the upcoming Full Partnership and sub-groups. ### Independent Review of Children's Social Care

The Government's Independent Review of Children's Social Care has now been published and makes a range of recommendations to support children in care, leaving care or at the edge of the care system. It recommends strengthening multi-agency arrangements with multi-disciplinary teams to support earlier help to families. It also makes recommendations to support involvement of wider family networks, recruitment of foster carers, and being ambitious for care experienced people in improving outcomes. ### Working Together 2018 Revisions

The Association of Safeguarding Partnerships (TASP) has informed us of the following update from the Department for Education regarding future revisions to the Working Together 2018 guidance:

"The Department for Education wants to inform you of their plan to update the Working Together to Safeguard Children (2018) statutory guidance. They intend to do this in two phases. Phase One will consist of a small number of factual updates, including changes to reflect the proposed statutory Integrated Care Systems planned for July 2022. Phase Two will be a more substantive update, requiring a public consultation. The Department for Education will continue to provide further updates on the process in due course.
