Local news

Publication - LSCPR Jason

A new Local Child Safeguarding Practice Review was published on 24 June 2021 regarding "Jason," a British teenager involved in County Lines. Learning themes include: the multi-agency No Recourse to Public Funds (NRPF) assessment, housing difficulties for vulnerable children, exclusion, and support for BAME children in schools. YOT Inspection Update

During May 2021, Her Majesty's Inspectorate of Probation (HMIP) inspected our Youth Justice Service (YJS). Although the final gradings will not be published until the end of August with the full inspection report, inspectors provided positive feedback during the inspection on the work of the YJS and wider partnership. A huge thank you to all multiagency partners who deliver youth justice services in Merton and who took part in showcasing our work at this inspection.

Adolescent Neglect Survey

The Promote and Protect Young People subgroup has produced a survey on adolescent neglect and how well it is understood amongst multi-agency partners. This is to assure the quality and effectiveness of the work being done to safeguard adolescents against neglect. Drug Edibles/Substance Misuse

Recently, Merton Borough has had several cases where young people have been approached to buy "edibles" on social media which have then been consumed in some cases. They look like sweets but contain drugs. There have been incidents where young people have suffered hallucinations which triggered anxiety or they have lost consciousness, requiring emergency treatment.

Cannabis can be mixed into cakes, tea, yoghurt, or sweets. The amount of cannabis in these products can vary greatly and sometimes other harmful drugs are added. The effects of consuming edibles are unpredictable, and it can be quite easy to accidentally take a larger dose.

If you are made aware of any social media accounts advertising these items, The Merton Safer Schools Team asks you to report this information to the Police, School or Crime Stoppers. Regional news

Serious Case Reviews

Members of our team recently attended a pan-London event, and some interesting learning was disseminated from serious case reviews in other London boroughs. Links to the full reports are in the titles:

Baby T - London Borough of Redbridge

Learning themes include: the dispersal of asylum-seeking mothers and their babies before the child is eight weeks old, effective interpreting services and access to advice on crying babies.

David - Bi-Borough

Learning themes include: the gap of support for autistic children with additional disabilities, residential treatment options for young people with high-risk behaviours and more conversation surrounding "callous and unemotional traits."

National news

National Policy, Research and Legislation

The Queen's Speech

On Tuesday 11 May 2021, the State Opening of Parliament was marked with the Queen's Speech which outlines the Government's plans for the parliamentary year ahead. Violence against women and girls and domestic abuse were highlights; a new Violence Against Women and Girls Strategy will be published to better target perpetrators and support victims.

Meanwhile, The Domestic Abuse Act 2021 will underpin Government's commitment to tackling domestic abuse. It will create a new offence of non-fatal strangulation and give the police new powers including Domestic Abuse Protection Notices. The Domestic Abuse Strategy will also focus on prevention and will be accompanied by £25 million of investment on programmes to work with perpetrators.

Finally, improvements will be made to the help and support provided for children and the families that care for them. It is continuing to champion 'Family Hubs' and encourages local authorities to make them a place for parents and carers to access local Start for Life services.

Child Death and Deprivation Research

The NHS has recently reported that about 700 child deaths could have been avoided each year in England by reducing rates of social deprivation. The research analysed the records of 3,347 children who died in England between 1 April 2019 and 31 March 2020. It identified a clear association between the risk of death and level of deprivation, for all categories of death apart from cancer. It concluded that more than a fifth (23%) of all child deaths might be avoided if all children, regardless of postcode, had the same mortality risk. You can read the report, in more detail, here.

An Ofsted review was published on 10 June and notes that schools and colleges cannot tackle sexual harassment and sexual violence, including online, on their own; the Government must also tackle the issue through the Online Safety Bill and other measures. The review makes several recommendations for Government, as well as the inspectorates, and one for safeguarding-children-partners: "Partners should work to improve engagement with schools of all types in their local area, tailoring their approach to what their analysis (produced in partnership with schools/colleges and wider safeguarding partners) indicates are the risks to children and young people in their local area."

Report on Missing Children

The charity, Missing People, is publishing a new report from a consultation project with looked-after or care-experienced young people. Looked-after children are disproportionately more likely to be reported missing. With the help of carers and social workers, Missing People has begun to explore views on what should happen and how best to support others who go missing. Headlines include young people's views on how relevant agencies should respond to them as well as a call to mitigate any issues that may cause a young person to go missing. Independent Child Trafficking Guardians Service

The ICTG Service has launched and is now accepting referrals in Merton and nationally. An ICTG referral should be made in addition to the NRM (National Referral Mechanism) referral. During this phase of the roll out, targeted testing of three recommendations from the Independent Review of the Modern Slavery Act in the following ICTG Sites will take place:

- Removal of the 18-month limit for ICTG support to ensure that the support provided is based on the individual needs of the child.
- Enable those children who need it, to continue to receive ICTG support following their 18th birthday (London and Warwickshire).
- Allow children who have a figure of parental responsibility for them in the UK to access one-to-one support where there is an exceptional need (Wales, the East Midlands, and West Midlands Combined Authority).

National Safeguarding Reviews and Reports

Child Safeguarding Practice Review Panel – Annual Report for 2020

Three headline messages: 1. To give a real and strong voice (and influence) to children. 2. The urgency of addressing what might be described as stubborn and perennial problems in multi-agency child protection practice. 3. The need to understand and evaluate robustly the impact of learning from rapid reviews as well as local and national practice reviews. Alan Wood Review of Multi-agency Safeguarding Arrangements

Key messages: The new reforms are embedding and 90% of people who took part in the survey have been positive about them. Resources are under "much stress" with reference to the ADCS Safeguarding Pressures report; central government does not demonstrate a joined-up culture. What Works for CSC – Analysis of Safeguarding Partners Annual Reports 19/20

Best Reports: These made use of a range of evidence sources (data, inspection, multi-agency audit, workforce feedback, and the views of children and families) to identify priorities and evaluate their impact. Weaker reports were descriptive rather than evaluative, with a focus on actions completed in relation to partnership priorities. <u>Analysis of Safeguarding Partnerships' yearly reports 2019-20: Overview report (whatworks-csc.org.uk)</u>
