# **Local News**

## Joint Annual Conference with the Adult Safeguarding Board

The MSCP joined the Merton Safeguarding Adults Board to deliver an Annual Conference focusing on the themes of Think Family and Transitional Safeguarding. The conference was well attended, and we were delighted to welcome keynote speakers from the Charlie Waller Trust and the Family Safeguarding Centre for Justice Innovation who delivered inspiring and informative presentations. ### **Full Partnership in February**

Thank you to everybody who attended our Full Partnership in February. A special shout out to Halima Mehmood, our Young Scrutineer, who presented the findings of the 'staying safe' elements of the Merton's Youth Residents Survey. It was a great opportunity to talk about how, as a Partnership, we are directly responding to the views of children and young people in Merton. Each of our sub-groups have been meeting with Halima to think through how we can strengthen this area.

We also talked about our Neglect Strategy and Neglect Toolkit, and welcomed a familiar face – Ann Marie Christian – a former colleague in Children, Schools and Families. Ann Marie talked to us about the different types of neglect and the role of us as partners in responding to children and young people at risk of, or experiencing neglect. We took away the importance of identifying affluent neglect and we will be sharing some additional resources on this on our website soon. We are looking for some representatives from across the Partnership who can support us with embedding our neglect strategy and toolkit so please get in touch if you would like to help with this important topic at MertonSCP@merton.gov.uk. Training and advice will be provided.

## **Multi-Agency Audits in Merton**

Our Quality Assurance and Practice Review Sub-Group has been busy over the last few months. In February we took the findings of our recent Section 11 audit to the Full Partnership. The Section 11 audit allows the MSCP to hold agencies to account regarding their safeguarding arrangements and practice, as well as inform our training needs. We were delighted to have such strong engagement from across our Partnership and want to say a huge thank you to everybody involved. Agencies have been able to identify their own actions and we will catch up with you all later this year to hear how you have got on progressing these. The QA Sub-Group will also oversee the delivery of a small selection of multi-agency actions. You can find more on our website Section 11 pages.

The MSCP have also undertaken an audit on Domestic Abuse and the lived experience of children and young people. Thank you to Margaret Mansfield, who has since sadly left us, for chairing the audit and everybody else who contributed. It has enabled some rich learning for the Partnership about the need to develop effective interventions that can 'stop the revolving door' of referrals. We will be working with our partners to take forward the audit recommendations. Our audits can be found on <u>our website</u>. Merton Children, Schools and Families Ofsted Inspection 2022

In February, Merton was given notice of an ILACS short inspection. Inspectors spent two weeks speaking with directors, heads of service, and practitioners within the Children, Schools and Families directorate and seeing examples of practice showcased. We are sure that CSF colleagues have had an opportunity to showcase some great work and we also thank all partners who contributed to the inspection. We look forward to the reading Ofsted's assessment when published in May.

The South West London Clinical Commissioning Group (CCG) are exploring the ways in which we can better support families to manage child and adolescent mental health challenges in the communities. # **Regional News**

## **Child Q Learning Review**

City and Hackney Safeguarding Children Partnership recently published a review involving Child Q, a 15-year-old girl who was strip-searched in her school without an appropriate adult present. ## **London Safeguarding Children Procedures - Changes**

On 31st March, the "London Child Protection Procedures" changed to the "London Safeguarding Children Procedures," following consultation. There have also been other significant changes to the layout of the website including:

- Core Procedures the order remains the same but two additional chapters have been added
- Safeguarding Partnership Arrangements includes agency responsibilities and partnership arrangements this is themed with some added content.
- Practice Guidance is now in alphabetical order with shorter titles in the index which hopefully makes it easier to locate what you are looking for.

Despite the change of name, internet searches for the "London Child Protection Procedures" and for the "London Safeguarding Children Procedures" will continue to function until September 2023. Colleagues that use a link to access frequently visited sections of the procedures may need to update their links.

## NHS London Violence Reduction Programme - New Social Prescribing Pathway

The NHS London Violence Reduction Programme is launching a new specialist Social Prescribing Pathway for children and young people at risk of violence in London. Designed as a preventative model, the pathway will specifically support the needs of young people aged 11-25 years old who may be at risk of violence, promoting change on an individual and community level. It focuses on young people and utilises the strengths of individuals who may have lived experience to connect with at risk young people and empower them to make better life choices.

# Arthur Labinjo-Hughes/Star Hobson

Work is progressing on the national review into the tragic deaths of Arthur Labinjo-Hughes and Star Hobson. The review is due to be published in May 2022. The updated terms of reference are available here.

## Centre of Expertise on Child Sexual Abuse - Communicating with Children Guide

Research and practice both show that it can take years for a child to get to the point where they feel able to tell someone about their experiences. It is vital that anyone who works with children knows how to recognise what is happening and understands how to help the child to have that conversation. The CSA has published a guide that brings together research and practice guidance to help give professionals the knowledge and confidence to act.
