#### **Ofsted SEND Revisit in Merton**


Back in September 2019, Ofsted highlighted several areas of concern with Merton's provision of SEND. Between 17 and 19 October 2022, inspectors from Ofsted and the CQC returned to the borough and spoke with children and young people with special educational needs and/or disabilities (SEND), parents and carers, and practitioners and managers across the local partnership.

We are very happy to announce that Merton's SEND partnership has now hit all targets for improvement set out by Ofsted and the Care Quality Commission (CCQ), which recognises the council and local NHS have "made sufficient progress in addressing all of the significant weaknesses identified at the initial inspection". We'd like to share our sincerest thanks to all partners, parents/carers and young people who contributed to this outcome, through collaborating over the past couple of years to achieve the improvements recognised by inspectors, as well as giving up their time to speak with inspectors.

#### Launch of VAWG Strategy, and achievement of White Ribbon Accreditation

Merton Council has launched its new strategy for the next three years to help prevent all forms of violence against women and girls (VAWG) and domestic abuse in the borough. The strategy is formed of five key priorities: to raise awareness and implement coordinated partnership working; to prevent VAWG through early intervention; to support victims; to hold perpetrators of VAWG to account; and to improve the safety of women and girls.

We are also proud to announce Merton Council has been awarded White Ribbon Accreditation and we would like to encourage you to promote White Ribbon within your organisation.

#### **Anti-Bullying Best Practice Toolkit**

In November, the MSCP launched its new Anti-Bullying Best Practice Toolkit, which has been created to support schools and other professionals prevent and deal effectively with bullying. The toolkit has been developed by the Merton Anti Bullying Operation Group with representatives from the Virtual Behaviour Service, the Virtual School, School Improvement, Youth Participation as well as staff and pupils from Merton's primary and secondary schools.

During the launch event on Thursday 10 November attendees heard from the Anti-Bullying Operational group as well as children and young people talking about bullying and the impact can have on them. The toolkit provides an overview of bullying and the types of bullying that young people may face. It also provides advice on how to support children who have been bullied and are targets of bullying.

An accompanying Guidance for Schools document provides additional information on the prevention of bullying, reporting of bullying, response and interventions. There is also model Anti-Bullying Policy that can be used as the basis for a school anti-bullying policy. # **Regional / National News**

#### **Updates to the London Safeguarding Children's Procedures**

This is a reminder that the following updates have recently been made to the London Safeguarding Children Procedures:

- Chapter CP6, Children Moving Across Borough Boundaries has been re-written. Please read the whole chapter <a href="here.">here.</a>
- There have also been other amendments to chapters CP2, 3, 4, and 7, as well as chapter PA 2. You can read these amendments here.

#### **National Reports, Reviews and Guidance**

#### **Ofsted Updates**

- A new <u>SEND Inspection Framework</u> will launch from early 2023, following consultation earlier this year. Ofsted and Care Quality Commission will continue to inspect local area partnerships together, but with a broader focus on outcomes for children and young people with SEND, rather than the previous focus on implementation of the 2014 reforms.
- As of 29 November, there is a new <u>Joint Targeted Area Inspection of the Multi-agency Response</u>
   <u>to Children and Families Who Need Help</u>, which refers to targeted early help practice and the
   interface with statutory children in need support. This is another multi-agency inspection, with
   three inspectorates involved Ofsted, Care Quality Commission and His Majesty's Inspectorate
   of Constabulary and Fire & Rescue Services. Preparations for the partnership will be overseen by
   the Early Help & Neglect MSCP Sub-Group.
- Ofsted is introducing a new, separate judgement to the <u>framework for inspecting local authority</u> <u>children's services (ILACS)</u>, about the experiences and progress of care leavers. This follows their recent consultation on changes to the framework, which saw over 90% of respondents support plans for a specific focus on care leavers.

#### **Updated Guidance for Safeguarding Partners**

There have been recent updates to the national Child Safeguarding Practice Review Guidance for Safeguarding Partners.

- The first paper explores the current guidance on the management of <u>bruising in non-mobile</u> infants in the light of published evidence and variations in practice.
- The second paper sets out findings from a <u>thematic analysis of rapid reviews and LCSPRs where</u> domestic abuse featured.

The guidance is particularly aimed at those involved in local child safeguarding practice reviews (LCSPRs) including reviewers, review panel members, and those responsible for decision-making around reviews. You can find a link to the full guidance here.

#### **Girl Guiding Survey**

A new survey has revealed that 19% of girls and young women say they did not feel safe in school, with girls and young women of colour less likely to feel safe at school than their white counterparts (65% compared with 70%). The poll by the Girl Guiding charity also revealed stark regional differences, with 22% of girls and young women in the north aged 11 to 16 blaming fear of sexual harassment for holding them back at school. The figure was 16% in London and the south. Similarly, 26% in the north of England said gender stereotyping was holding them back at school, compared with 18% in London and the south. The problem was particularly acute among LGBTQ+ girls and young women, with 37% complaining about gender stereotyping at school. Girlguiding's chief executive, Angela Salt, said: "It is shocking how many girls and young women, some as young as 11 years old, don't feel safe at school, on social media or out in public. Our research shows just how common discrimination, stereotyping and sexism is in our society and how unsurprisingly this creates barriers to happiness, confidence, and success."

#### **Girls Speak: Pushed Out Left Out**

Girls Speak is a national research project run by the Agenda Alliance that focuses on the lives of girls and young women with multiple unmet needs and their experiences with accessing services. Their report, Pushed Out Left Out, was published in November 2022 and researched, through interviews, the service experiences of 36 young women aged between 13 and 26 with multiple unmet needs. It found that girls and young women faced markedly different risks to that of boys and young men, such as sexual abuse, domestic violence and development of depression and anxiety. It also found that statutory services are often inaccessible to girls and young women with multiple unmet needs due to barriers such as thresholds and long waiting lists. #### National Safeguarding Review into Children with Disabilities and Complex Health Needs

Phase 1 of the Independent National Child Safeguarding Practice Review Panel's review into safeguarding children with disabilities and complex health needs in residential settings was published in late October. The report is available to read in more detail <a href="here">here</a>.

Its aim was to make sense of how and why a significant number of children with disabilities and complex health needs came to suffer very serious abuse and neglect whilst living in three privately provided residential settings. It brings into sharp relief how the voices and experiences of this group of children are too often marginalised, misrecognised, and hidden from public sight.

As part of Phase 2 of this review, Merton Council has reviewed the small number of children's cases this applied to locally. Findings highlighted good practice with some areas for improvement, and the learning will be shared with the partnership in the new year.
